CREDAI-MCHI hosts expert panel to decode Bombay High Court's GST relief verdict on redevelopment projects

On 8th May 2025 CREDAI-MCHI hosted a focused knowledge seminar at its Mumbai office to decode the implications of the recent Bombay High Court order in the matter of M/s Shrinivasa Realcon Pvt. Ltd. vs. Deputy Commissioner, Anti-Evasion Branch, a ruling that has delivered significant GST relief for homeowners involved in redevelopment projects.

The seminar featured insights from Mr. Sunny Bijlani (CREDAI-MCHI), Mr. Rohit Jain, and Mr. Harsh Shah (ELP). Mr. Bijlani emphasized the need to resolve GST-related ambiguity and excessive development charges to unlock Mumbai's redevelopment potential. Mr. Shah warned against misinterpretation of court rulings, noting that GST risks remain unless clarified by the GST Council or a larger bench. Mr. Jain highlighted how cascading GST layers are making projects unviable, calling for urgent tax reclassification of development rights.

With over 25,000 buildings in MMR eligible for redevelopment, the judgment is expected to boost urban renewal. CREDAI-MCHI reaffirmed its commitment to supporting redevelopment with clearer frameworks and announced the second edition of the EODR Exhibition to drive awareness and solutions.



CREDAI-MCHI, in collaboration with MPCB and WRI India, conducts a capacity-building workshop

In a step toward cleaner urban development, On 9th may CREDAI-MCHI, in collaboration with the Maharashtra Pollution Control Board (MPCB) and WRI India, hosted a Capacity Building Workshop on Air Pollution Mitigation at Construction Sites. The session brought together engineers, safety officers, and project managers from across MMR to strengthen on-ground implementation of dust control measures.

Key focus areas included fogging, wheel washing, and enclosing dust-generating activities, along with the adoption of real-time air quality monitoring and compliance tracking. Experts from WRI India led technical sessions on using cost-effective tools and aligning with MPCB guidelines.

Revati Shidhaye (BMC), Keval Valambhia (CREDAI-MCHI), and Sree Kumar Kumaraswamy (WRI India) emphasized the urgent need for sustainable construction practices that prioritize public health and environmental responsibility.

CREDAI-MCHI reaffirmed its commitment to promoting green construction and continuing collaboration with civic authorities to build a cleaner, healthier Mumbai.

The workshop was attended by over 35 developers and their staff.









CREDAI MCHI Delegation Meets Hon'ble Environment Minister Smt. Pankaja Munde

On 17th May, a delegation led by Shri Boman Irani (Past President, CREDAI-MCHI and Chairman, CREDAl National), along with Shri Dhaval Ajmera (Hon. Secretary, CREDAI-MCHI), Shri Rushi Mehta, Shri Madan Jain (President, CREDAI-MCHI Navi Mumbai Unit), Shri Rajesh Prajapati, Shri Rajesh Gupta (President, CREDAI-MCHI Kalyan-Dombivli Unit), Shri Keval Valambhia, and Shri Harish Gupta, met with Hon'ble Environment Minister Smt. Pankaja Munde to discuss critical environmental concerns affecting the real estate sector.

The discussion focused on expediting hearings and the issuance of NOCs for CRZ-related redevelopment proposals, evaluating non-CPA/SPA projects based on the updated MPCB CEPI scores in line with recent High Court directions, and presenting a joint CREDAI-MCHI and CREDAI National proposal to plant one million trees along the Coastal Road Project and in the Western Ghats.

The Hon'ble Minister assured the delegation of a positive review and offered her valuable guidance on all matters raised.

On May 18th, the meeting with Shri Rajendra Mirgane, Chairman Advisory Committee, Housing Department was attended by Shri Keval Valambhia (Chief Operations Officer) and few Office bearers of PEATA.

Shri Rajendra Mirgane informed about the role of the advisory committee in resolving issues related to self-redevelopment, MHADA and SRA projects. He presented a detailed report to Hon'ble Chief Minister Shri Devendra Fadnavis on the issues related to redevelopment of project and now he has been requested to submit report on issues related to SRA after consultation from all the stakeholders. Accordingly, PEATA and CREDAI-MCHI explained him several issues such as increase in the TDR compensation, issues in the funnel zone, GST on rehab component, valuation of Private land encroach by slum dwellers, digitization of records etc.

Shri Rajendra Mirgane took note of all the points and informed that a second round of meeting will be called to discuss all these issues in detail so that a report can be presented to Hon'ble Chief Minister.

CREDAI NCR - Haryana Zonal Chapter GBM

The General Body Meeting of CREDAI NCR – Haryana Zonal Chapter, held on 7th May at Hotel Westin, marked a significant step forward in reinforcing industry unity and addressing pressing challenges. Shri Manish Agarwal was unanimously appointed as President for the 2025–2027 term, along with other office bearers, bringing in a dynamic leadership team backed by a strong Governing Council.

A major concern raised was the recent issuance of arrest warrants by HARERA, prompting the House to propose urgent dialogue with the Hon'ble Chief Minister and Housing Minister to seek reforms including mediation mechanisms and protection of civil liberties. Delays due to the non-functional Haryana EIA Committee were also discussed, with a resolution to escalate the matter with the State Environment Ministry.

To improve coordination, eight sub-committees were formed focusing on key areas like Power, Environment, Legal, DTCP, GMDA, Technology, Mediation, and Media & PR. These will serve as dedicated channels for departmental engagement, supported by proposed quarterly meetings with authorities.

The CREDAI National 5-point agenda for Viksit Bharat was shared, emphasizing workforce skilling, regulatory simplification, and sustainability. Members also recommended the creation of a technology sharing platform, vendor rating system, and a centralized policy repository. The meeting closed with a renewed commitment to transparent leadership, proactive advocacy, and meaningful collaboration for a stronger future.



CREDAI NCR (Western U.P.) Delegation Met Shri Nitin Kumar Saxena, Deputy Secretary, UP RERA

On Tuesday, 6th May 2025, a delegation from CREDAI NCR (Western U.P.) met Shri Nitin Kumar Saxena, Deputy Secretary, UP RERA and Conciliator, to foster open dialogue between the regulatory authority and key real estate stakeholders in Western Uttar Pradesh.

The delegation raised critical issues around procedural simplifications, compliance clarity, and the functioning of the RERA Conciliation Forum. Shri Saxena reaffirmed UP RERA's commitment to transparent, efficient regulation and welcomed CREDAI's proactive role in improving the framework.

The meeting ended on a positive note with a shared resolve to continue regular communication and collaborative problem-solving. CREDAI NCR (Western U.P.) extended its gratitude to Shri Saxena and UP RERA officials for their support and engagement.









CREDAI NCR (Western U.P.) Holds EC, GC Meeting to Address Regional Challenges

On 9th May 2025, CREDAI NCR (Western U.P.) held its Executive Committee and Governing Council meeting to address key challenges impacting real estate across Noida, Greater Noida, Yamuna Expressway, and nearby areas.

Discussions centered on regulatory hurdles with local authorities, delays in approvals, and the need for transparent governance. A dedicated session was held on Noida Sport City, where members raised concerns over unclear development terms and compliance issues. The association resolved to seek direct dialogue with Noida Authority officials.

Members also flagged GST notices issued to developers, especially in Greater Noida (West), citing ambiguity in tax interpretations. CREDAI NCR (Western U.P.) will pursue legal remedies and engage with GST officials to seek clarity.

The meeting reaffirmed CREDAI NCR's commitment to member advocacy, regulatory engagement, and driving systemic reforms for smoother operations and sustainable growth.



On 15th May 2025, a senior delegation from CREDAI NCR (Western U.P.) met with the Hon'ble Chairman and Secretary of UPRERA to seek clarity on recent regulatory directions and strengthen coordination with the Authority.

Key discussions revolved around the 8th May directive under Section 37, which officials clarified applies specifically to unfinished "canvas flats." They reiterated that possession must align with specifications in the Builder-Buyer Agreement, and any deviation could result in non-compliance.



CREDAI NCR (Haryana) Delegation Meets Police Commissioner, Gurugram to Discuss Legal and Operational Concerns

On 14th May 2025, a delegation from CREDAI NCR (Haryana), led by President Shri Manish Agarwal, met with the Commissioner of Police, Gurugram, to discuss recent legal developments impacting the real estate sector. The team highlighted the implications of the Punjab & Haryana High Court's Vatika judgement, which nullifies certain RERA enforcement powers and urged withdrawal of police actions based on now-invalidated orders.

The Commissioner assured the delegation that a legal opinion would be sought before proceeding. He also cautioned about the invocation of Section 111 of the Bharatiya Nyaya Sanhita in serious real estate fraud cases and urged developers to maintain legal compliance. Concerns over procedural confusion due to multiple advocates were addressed, with members advised to designate a single legal representative per case.

In a constructive move, CREDAI proposed a joint Mediation Cell with police officials, which was promptly approved by the Commissioner. Issues related to unauthorized protests were also raised, with assurances of legal enforcement.

The meeting reaffirmed CREDAl's commitment to constructive dialogue and collaborative solutions for sectoral challenges.

Officials also confirmed that possession on the basis of Deemed OC, with all valid NOCs, remains permissible. Developers were cautioned against demanding additional payments for completing flats, stressing strict adherence to agreed terms.

The earlier order on dwelling unit registration dated 29th May remains fully in effect and is not superseded by the new directions. The meeting reflected a shared commitment to regulatory clarity and consumer protection.









Meeting of CREDAI NCR (Haryana) Sub-Committee on Issues related to Power and HERC

Gurugram, 16th May 2025 — Members of CREDAI NCR (Haryana)'s power sub-committee held a focused discussion to address key concerns related to power supply, infrastructure costs, and engagement with DHBVN and HERC.

The group strongly opposed the current push for multi-point electricity connections, citing safety, efficiency, and cost concerns. Members advocated for the single-point connection model, which allows better load optimization, simpler billing, and improved safety.

Concerns were also raised over unrealistic solar norms—such as blanket 16 kW allocations per flat—and outdated infrastructure requirements like switching substations and double-run cables, which increase costs without clear benefits.

It was decided to engage a qualified private consultant to prepare a detailed technical presentation, backed by data and multi-city comparisons. The committee also emphasized the need to reshape the developerauthority relationship into a partnership model, reflecting developers' role as major, compliant electricity consumers.

Key issues prioritized for escalation include removal of redundant infrastructure requirements, review of multi-point connections, and rationalization of bank guarantee norms. CREDAI Haryana reaffirmed its commitment to advocate practical, technically sound solutions through structured engagement with power authorities.



Meeting was organized by CREDAI NCR (Haryana) to discuss Vendor Management, Technology Integration & App Development

On 16th May 2025, CREDAI NCR (Haryana) members held a strategic meeting focused on transforming vendor management, streamlining procurement, and leveraging technology through app development.

The group called for stronger vendor accountability, agreeing that key vendors must resolve past issues before entering new discussions. A collaborative procurement model was proposed to pool demand and negotiate better rates for materials like cables and meters.

Members also agreed to build a shared, dynamic vendor database and develop a Haryana-specific CREDAI app, beginning with modules for vendor management and HR. Data collection will begin immediately via Google Forms and Sheets, forming the backbone of the platform.

To ensure transparency, a vendor rating system—featuring anonymous, objective reviews—was suggested. The long-term goal is to create a smart, scalable app to centralize vendor information, support collaborative buying, and track performance.

Shri Varun Aggarwal, Shri Harvinder Singh Hora, and Shri Gurpal will lead the data framework initiative, with app vendor evaluation running in parallel. The initiative marks a major step toward a more efficient, tech-driven real estate ecosystem in Haryana.



Meeting to discuss Key Issues and Recommended Actions by CREDAI NCR (Haryana) Environment Committee

On May 21, 2025, the Environment Committee of CREDAl NCR (Haryana) held a focused meeting to deliberate on key environmental challenges that continue to hamper real estate and infrastructure development in the region. Developers face significant delays in obtaining environmental clearances due to regulatory overlaps and procedural hurdles. One of the major concerns raised was the non-acceptance of Environmental Clearance (EC) applications without a valid development license. This sequential dependency contradicts the Government of India's principle of parallel processing and causes avoidable project delays. The Committee also highlighted the repeated delays in the constitution of the State Environmental Impact Assessment Authority (SEIAA) and the State Expert Appraisal Committee (SEAC) in Harvana. The lack of continuity in these bodies creates a procedural vacuum, unlike in states such as Maharashtra and Gujarat, where timely approvals boost investor confidence.

pressing issue is the inconsistent interpretation of the Ministry of Environment and Forests (MoEF) guidelines for granting Consent to Establish (CTE), with State Pollution Control Boards (SPCBs) often following varied approaches. This lack of uniformity further slows down project timelines. Additionally, temporary structures such as site offices and sales galleries measuring under 20,000 sqm continue to be subjected to unnecessary EC scrutiny, despite being exempt as per current guidelines. Members were informed that CREDAI National is actively engaging with authorities to resolve this matter. The Committee also noted that Haryana lags behind other progressive states in granting ECs,

affecting the ease of doing business and deterring potential investments.

There is also ambiguity surrounding the developer's responsibility post-handover to Residents Welfare Associations (RWAs). This gap often leads to confusion, disputes, and a lack of clarity on liabilities. The Committee recommended the creation of a formal documentation framework outlining roles and responsibilities post-handover, along with timely intimation to relevant departments to ensure legal and administrative clarity. In conclusion, the Environment Committee of CREDAI NCR (Haryana) reaffirmed its commitment to collaborate with government authorities, regulatory agencies, and industry stakeholders to address these issues. Streamlining environmental processes and ensuring transparent, time-bound governance are vital to restoring investor confidence and ensuring sustainable growth in Haryana's real estate sector.



CREDAI NCR - Western U.P. Delegation Meets Noida Authority

On 20th May 2025, a delegation from CREDAI NCR – Western U.P. met with senior officials of the Noida Authority to raise five pressing concerns affecting the real estate sector in the region. The key issues discussed included the recent directive mandating the registration of the Agreement to Lease (ATL) even before physical possession is handed over, which has led to confusion among developers and homebuyers.

The delegation also urged the Authority to rationalize the inconsistent and arbitrary demands related to Sports City projects in Sectors 150, 78, and 79. Another major point was the need for implementation of the Uttar Pradesh IT & ITES Policy 2022 at the local Noida level, which could significantly boost the IT ecosystem and attract investments. Developers also recommended amendments to the existing Noida IT Park Development Policy to align it with current industry requirements and support vertical growth.

Additionally, urgent resolution was sought for long-pending registry issues in the Noida World One project by CBS International, which are affecting buyers and investors. The Noida Authority acknowledged these concerns and assured that each matter would be reviewed with due consideration. CREDAI NCR – Western U.P. reiterated its commitment to constructive engagement for the sector's sustainable growth.


