


5th Meeting of the Central Advisory Council




**CSR Skilling Initiative**







Meeting with MahaRERA Chairman Shri Manoj Saunik

On 3rd September 2025, President Shri Sukhraj Naharji commenced his tenure with a high-level open forum meeting with MahaRERA Chairman Shri Manoj Saunik Ji, accompanied by Shri Rushi Mehta (Secretary), Shri Dhaval Ajmera (Sr. Vice President), Shri Asif Gani Deriya (MC Member), Shri Gaurav Gupta (Thane President-Elect), and Shri Keval Valambhia (COO).

The discussions revolved around key reforms to streamline processes and improve the ease of doing business. The Chairman acknowledged that the decision of designating a landowner as promoter should rest with the developer when the landowner had no obligations. Scrutiny of projects was set to focus only on critical parameters such as floors, flats, and basements, thereby avoiding unnecessary technical queries. An auto-edit feature was also announced to minimize delays caused by raised queries.

To address challenges with the new MahaRERA portal, CREDAI-MCHI directly collaborated with PWC's software team to resolve glitches. Furthermore, MahaRERA assured faster resolution through bi-monthly review meetings and encouraged members to flag issues in real time.

The meeting marked a constructive step toward greater efficiency, transparency, and regulatory ease for developers.



Meeting with MMRDA Chief Dr. Sanjay Mukherjee

On the request of CREDAI-MCHI, a joint delegation comprising members from MCHI Bhiwandi and MCHI Palghar-Boisar Units met with MMRDA Commissioner Dr. Sanjay Mukherjee and his team on September 23, 2025, to discuss pressing issues faced by the Bhiwandi region.

The meeting was attended by 21 members of CREDAI-MCHI, led by Hon. Secretary Shri Rushi Mehta, along with Shri Keval Valambhia (COO, CREDAI-MCHI), Shri K.K. Duraj (President, MCHI Bhiwandi), Shri Punit Gosrani (Committee Member, MCHI Bhiwandi), and other local developers.

# **CREDAI National Capital Region**



CREDAI NCR (Western UP) Meets UP RERA on Key Developer Concerns

Representatives of CREDAI NCR (Western U.P.), including the Secretary, CREDAI NCR and Secretary, CREDAI Western U.P., held a detailed meeting with the Chairman and senior officials of UP RERA on 5th September 2025, followed by a Video Conference on 15th September 2025, to present key concerns faced by developers in the implementation of RERA regulations.

The delegation highlighted major challenges, including the impractical linkage of RERA certificate validity with the initial sanction plan period, prolonged delays in the closure of RERA bank accounts even after completion/occupancy, irregularities in the recall of Recovery Certificates (RCs) despite appeals or settlements, and technical glitches where uploaded completion/occupancy certificates were not displayed on the portal.

CREDAI NCR emphasized that addressing these issues through practical reforms would streamline operations, reduce financial stress on projects, and build greater confidence among homebuyers, developers, and regulatory authorities alike. The association expressed hope that UP RERA would consider these submissions positively and initiate corrective measures in the interest of all stakeholders.





CREDAI NCR Met New U.P. RERA Conciliator to Strengthen Developer - Homebuyer Relations

On 23rd September 2025, representatives of CREDAI NCR (Western U.P. and Ghaziabad) met Shri Aawdesh Dubey, Retired District Judge, who had recently joined as Conciliator at U.P. RERA.

The discussions focused on strengthening the relationship between developers and homebuyers through greater transparency, communication, and trust-building. Both sides emphasized that an effective conciliation and mediation mechanism was critical to resolving disputes fairly and expeditiously.



CREDAI NCR representatives highlighted the need for a time-bound framework for dispute resolution to minimize delays and reduce friction between stakeholders. Shri Dubey assured that his role as Conciliator would aim to make the process more balanced, transparent, and solution-oriented, benefitting both homebuyers and developers.



#### CREDAI NCR Initiates Scientific Study with IIT Delhi on Construction and Air Quality in NCR

CREDAI NCR took a major step towards addressing the issue of air quality and construction-related dust in the National Capital Region. On 24th September 2025, the Secretary and Joint Secretary of CREDAI NCR held a detailed meeting with Professor Sagnik of IIT Delhi to initiate an in-depth study, which was expected to commence in the following days.

The study was planned to cover eight major cities of NCR and aimed to provide a scientific and evidence-based understanding of the actual contribution of construction activities to air pollution.

The discussions underlined the need for a balanced approach that safeguarded both environmental and developmental interests, with key focus areas including source apportionment to identify and quantify construction's true share in overall pollution, targeted restrictions to ensure that bans applied only in critically high AQI zones, relief for compliant sites that adhered to prescribed dust-mitigation norms, and balanced regulation to prevent compliant developers from facing overlapping penalties.

CREDAI NCR representatives emphasized that this collaboration with IIT Delhi reflected their commitment to finding practical, science-backed solutions to environmental challenges, and noted that the study's findings would assist policymakers in designing fair, focused, and effective measures to reduce pollution without stalling responsible construction.




### India's real estate mkt to reach \$5-10 trillion by 2047: Report

India's real estate market is projected to touch \$5-10 trillion by 2047, contributing nearly one-fifth of the country's gross domestic product (GDP), said a report by Colliers and Confederation of Real Estate Developers' Association of India (Credai). India's GDP, currently \$4 trillion, is estimated to rise to \$35-40 trillion by 2047. Real estate, valued at \$ 0.3 trillion (6-8 per cent of GDP), is forecast to form 14-20 per cent of GDP by then, aided by urbanisation, infrastructure growth. Residential sales are expected to grow from 0.3-0.4 million units in 2025 to 0.8-1.0 million by

REALTORS' bodies Credai and Naredco have said strong economic growth in the June quarter will boost consumer confidence and increase demand for residential as well as

commercial properties.
"The strong GDP growth of
7.8 per cent demonstrates the resilience and potential of our economy. This positive mo-mentum is encouraging for the real estate sector and will boost investor and consumer confidence," Credai National President Shekhar Patel said.

He said the industry looks forward to the proposed GST reforms, which will further boost demand. NAREDCO President G

Hari Babu also said the strong GDP growth augurs well for the real estate sector as it would boost demand, especially dur-ing the upcoming festive sea-son. India's economy grew by a stronger-than-expected 7.8 per cent in April-June, its fastest pace in the past five quarters. The gross domestic product (GDP) growth in the first quarter of the ongoing fiscal year was mainly driven by good showing by the farm sector, and also helped by ser-vices like trade, hotel, financial and real estate, according to the latest government data released on Friday.

The previous highest pace

of growth in the country's GDP was recorded at 8.4 per cent during January-March 2024, as per the data. India remains the fastest-growing major economy, as China's GDP growth in the April-June period was 5.2 per cent.

Housing sales increased sharply during the 2022-24 calendar years. However, the demand slackened in the first half of 2025 because of a sharp rise in prices post-COVID pandemic.
