

The month of November was marked by several significant milestones, including the successful organization of convocation events, the launch of dedicated women batches, and the achievement of the highest enrolment numbers recorded in this financial year.

CREDAI continued to strengthen its skilling initiatives for construction workers across member cities. Training activities were conducted at multiple active sites, with steady participation and improved engagement from developers and training partners.

A total of 1,962 construction workers were enrolled and benefited through 62 fresh batches conducted nationwide which marks a strong operational performance and continued expansion of CREDAI's skilling footprint. Vijayawada, Indore, and Nagpur have also been recently added to CREDAI's skilling program as part of the expansion.





The certification distribution events held for construction workers trained under CREDAI's Skilling Initiative at Bhopal and Ghaziabad region. These ceremonies were organized in collaboration with the respective empaneled training partners and developers in coordination with CREDAI National.

In Bhopal, the certification program witnessed active participation from site management teams, developers, and training staff, who appreciated the efforts of the workers and encouraged them to utilize their enhanced skills productively and A total of 105 workers were awarded certifications.

Similarly, in Ghaziabad, the distribution ceremony was conducted with strong support from the developer team and training partner's, reinforcing the value of structured skilling in improving work quality and safety standards on-site and more than 60 construction workers received industry-recognized certificates in event.

CREDAL AP made a representation to the Hon'ble Minister of Home Affairs and Disaster Management



Vangalapudi Anitha, highlighting the challenges arising from the recent regulatory change wherein buildings up to 24 meters are no longer categorized as 'high rise' under the revised municipal rules, and requested that the process of obtaining a No Objection Certificate (NOC) from the Fire Department for such buildings be made non mandatory or suitably streamlined; the Hon'ble Minister responded positively and assured CREDAI Andhra Pradesh of a constructive resolution regarding the implementation of the revised high rise definition and the related approval process, particularly with respect to the Fire Department NOC for buildings up to 24 meters.

Meeting on Maharashtra State Rental Housing Policy

A detailed presentation on the upcoming Maharashtra State Rental Housing Policy was held on November 19, 2025, led by Shri Sanjeev Jaiswal (I.A.S.), Vice President, MHADA. The session focused on creating a strong, modern rental housing ecosystem across the state.

The policy aims to provide short-, medium- and long-term rental homes for students, migrant workers, displaced families, and people across all income groups. It also encourages the reuse of government buildings, rapid modular construction, and better land use to quickly create new rental housing stock.

To make the model attractive, the policy offers major incentives such as free additional FSI, 50% reduction in development charges, property tax waivers, Rs. 500 stamp duty, 10-year income tax exemption, and faster depreciation benefits. It also promotes private participation and PPP models for smooth operations and maintenance.

A dedicated digital portal will help ensure transparency and ease of use through verified listings, E-KYC, police verification, online rental agreements, rent payment facilities, a grievance redressal system, and real-time dashboards for the government.

Overall, the policy represents a tech-driven and incentive-based approach to boost affordable rental housing across Maharashtra.

During the interaction, MMRDA shared its vision for the Mumbai Metropolitan Region and highlighted key infrastructure projects that are reshaping the future of MMR. These include the expanding metro network, the Mumbai Trans-Harbour Link, and several transit-oriented development corridors. Such initiatives aim to boost connectivity, support urban growth, and position MMR as a \$300 billion economy by 2030, strengthening its role as India's economic capital and a leading global investment hub.

The meeting was attended by Rushi Mehta, Prashant Khandelwal, Mukesh Patel, Priya Gurnani, Arshad Balwa, Nimish Ajmera, Abhishek Sharma, Keval Valambhia, Harish Gupta, and Sanjay Phope.

sites. So far, vendors have installed 662 sensors, and 251 more installations are in progress. The installation progress and dashboard integration status of each vendor were also examined.

CEEW reported that 400 devices have been integrated with the centralised dashboard, of which 283 devices are active, and 117 devices are inactive. Vendors highlighted delays due to issues such as lack of electricity or Wi-Fi at sites, pending fabrication work, and non-receipt of data from project proponents.

A list of construction sites with inactive pollution indicators will be shared with the Environment & Climate Change Department. The Hon. AMC (City) instructed the department to conduct site visits, verify vendor submissions, and issue compliance notices as per High Court directions. Necessary action will be taken against sites found to be noncompliant.

CREDAI NCR Delegation Flags C&D Waste Concerns at UPPCB Pollution Review Meet in Greater Noida

A CREDAI NCR delegation, along with representatives from its Western U.P. and Ghaziabad Chapters, participated in a high-level pollution review meeting convened by the UP-Pollution Control Board in Greater Noida on 7 November 2025, as part of concerted efforts to address deteriorating air quality across the Delhi-NCR region. Chaired by senior leadership, including Dr. Arun Kumar Saxena, the meeting brought together multiple government bodies and key stakeholders to review on-ground implementation of anti-pollution measures such as dust mitigation at construction sites, GRAP enforcement and hotspot management.

CREDAI used the platform to reaffirm the real estate sector's commitment to sustainable, regulation-compliant practices and highlighted proactive steps already being taken by its members, including dust suppression, use of anti-smog guns, material covering and adherence to environmental norms.

A key intervention was made by Mr. Nikhil Hawelia, Joint Secretary, CREDAI NCR, who raised concerns regarding gaps in the Construction and Demolition (C&D) waste management system in Gautam Buddh Nagar, stressing the need for a more organised collection, transportation and processing mechanism to ensure scientific disposal.
