

Rules and guidelines for CNARE 2025

- All sections of the nomination form must be duly completed.
- Fields marked with an asterisk (*) are mandatory.
- Applicants may nominate one or more projects, provided each nomination is in a separate form and is accompanied by the required documents and presentation.
- The nominated project must have all the necessary approvals. Crisil reserves the right to request documentary proof at any time during the evaluation process.
- Each nomination must include a cover letter on the company's letterhead signed by an authorised signatory.
- Crisil reserves the full right to reject any nomination at its sole discretion and has no obligation to provide reasons.
- All nominations plus information requirements / documents must be submitted on or before **September 27, 2025.**
- Late submissions may not be accepted to ensure the smooth functioning of the internal evaluation process and to ensure the event is held on schedule.
- Each nomination must be accompanied by the following documents (soft copy) to ensure the entry is not disqualified:
 - Signed declaration letter on company letterhead and stamped by the authorised signatory, as per the format in Annexure 1
 - Geotagged photographs of the project (minimum 10 images)
 - RERA certificate for the nominated project
 - Occupancy certificate/completion certificate/building use certificate from statutory authority for the nominated project
 - Project brochure
 - Audited/provisional financial statement of the company/firm for last 3 years (self-certified in case of Provisionals)
 - Presentation highlighting details of nominated projects and its USP
 - Category-specific documents listed in the information requirement Excel sheet
- A non-refundable nomination fee of Rs. 10,000 + 18% GST is applicable for each category nomination. Multiple nominations will attract the fee separately for every category entered.
