

Rules and Guidelines

CREDAI Awards for Real Estate Excellence 2026

- All sections of the nomination form must be duly completed.
- Fields marked with an asterisk (*) are mandatory.
- Applicants may nominate one or more projects, provided each nomination is submitted in a separate nomination form and is accompanied by the required documents and presentation.
- The nominated project must have all the necessary approvals. CRISIL reserves the right to request documentary proof at any stage during the evaluation process.
- Each nomination must include a cover letter on the company's letterhead signed by an authorised signatory.
- CRISIL reserves the sole right to reject any nomination at its discretion and is under no obligation to provide reasons.
- All nominations, along with the required information and supporting documents, must be submitted on or before 15 September 2026.
- Late submissions may not be accepted to ensure smooth evaluation and adherence to the event timeline.

Mandatory Documents

- Minimum 10 geotagged photographs of the project
- RERA Registration Certificate of the nominated project
- Occupancy Certificate / Completion Certificate / Building Use Certificate issued by the statutory authority
- Project brochure
- Audited or provisional financial statements for the last three financial years (provisional statements must be self-certified)
- Presentation highlighting the nominated project and its unique selling propositions (USPs)
- Category-specific documents as listed in the Information Requirement Excel Sheet

Jury Decision

- **The decision of the Jury shall be final, binding and not subject to appeal or review.**

Nomination Fee

- A non-refundable nomination fee of ₹10,000 + 18% GST is applicable per category nomination.
- Multiple nominations will attract a separate fee for each category.
